Opening remarks from Ron Hoover at 7:05. Ron shared his thoughts about the caring and impact of ministry through the love of Jesus Christ. Ron shared a passage of scripture "Thou shall love thy neighbor as thyself" from Matthew 22:39. Ron also recognized Eddie Fletcher who was called to serve and thankful for those who joined him during the time of discernment.

Ron Moore provided the devotion at 7:08. Shared a brief story about Albert Einstein traveling on a train and could not find his ticket. Ross Olhausen – Where Will We Land?

Ross and the committee discussed options on where we go after the vote to disaffiliate. The committee discussed the following topics.

- First The Conclusion: What options are available? Do we affiliate with GMC or seek options as an Independent Church. Ideally would like the conclusion in 6-12 months.
- Criteria Considered Theological, Interim, Long Term
- Decision Critical Criteria
- Denominations Considered
- Denominations Eliminated from Consideration
- Denominations Considered After eliminations.
- GMC Pros and Cons
- Independent Pros and Cons

Ross is working on an updated version of his presentation. We will post the updated version (with detail of each bullet point) in the resource section of the Church Center App.

<u>Bill Coffeen – Financial Obligations</u>

- Disaffiliation Fees
 - 12-month apportionment
 - Portion of unfunded pension liability
- Already raised through pledges 45% of the \$207,689.83
- Stretch goal to raise \$220,000 to cover unexpected / additional expenses.
 - o Example: Removal of Flame from Cross above South Campus Sanctuary
- Prayerfully asking and encouraging others to pledge to help the church achieve its financial obligations.
- The Church is in a great financial position moving forward.
- \$5,100 in grants from the UMC have to be reimbursed as part of the disaffiliation fees.
- Financial obligations will be paid by the end of the calendar year.

Robert Mooney - Signed Agreement

- 1. DWMC held a Church Conference on 8/27/23 where disaffiliation from United Methodist Church was approved by at least 2/3 of the voting church members.
- 2. A Disaffiliation Agreement was signed by the DWMC Board of Trustees during the Church Conference referenced above.
- 3. The agreement included, but was not limited to, the following points:
 - a. The Disaffiliation Agreement must be ratified by a simple majority vote during the next North Ga. Conference meeting on Nov. 18th, 2023.
 - Should DWMC comply with all obligations within the Disaffiliation Agreement in a timely manner, the disaffiliation from the United Methodist Church will be effective Nov. 30th, 2023.
 - c. DWMC shall have the right to retain its real and personal property (tangible and intangible) free of charge, once it pays to the Annual Conference a sum equal to the following:
 - i. Any costs associated with transfer of title.
 - ii. Any unpaid apportionments for the 12 months prior to Nov 30th, 2023.
 - iii. An additional 12-month apportionment as calculated by the Annual Conference.
 - iv. DWMC pro-rated share of any unfunded pension obligations.
 - v. Any other funds related to conference-provided benefits that are direct-billed to DWMC for benefits provided up to 30 days past Nov. 30th, 2023.
 - vi. Any grants or direct contributions that have been paid by Annual Conference to DWMC within a 4-year period preceding Nov. 30th, 2023.
 - d. Calculation from Item "c" above is approximately \$233,986.13. (\$207,689.83)
 - e. DWMC must either satisfy or transfer any other debts to its new entity.
 - f. DWMC must cease the use of intellectual property of the United Methodist church, including but not limited to, the Cross & Flame insignia. All paraments, hymnals and worship elements must be returned to the Conference.
 - g. DWMC and/or the new entity must seek its own tax-exempt status.
 - h. SHOULD DWMC FAIL TO SATISFY ALL OBLIGATIONS WITHIN THE AGREEMENT BY DECEMBER 30TH, 2023 THE AGREEMENT BECOMES NULL AND VOID.
